

Terms and Conditions of use

This is a summary of the terms and conditions that apply to your purchase and use of this voucher (“Voucher”) at the vendor named on the voucher and the terms and conditions of 800tickets.com that apply when you bought your voucher

These terms and conditions collectively are referred to as (“the Conditions”).

1. All Vouchers are sold subject to the Conditions. Please read the Conditions carefully before purchase, and raise any queries with The Vendor or The Agent (as relevant) before purchase. Your purchase of a Voucher constitutes your acceptance of these Conditions.
2. You must produce a valid Voucher upon arrival at The Venue. Your Voucher may be invalidated if any part of it is removed, altered or defaced. The Vendor will not be responsible for any Voucher that is lost, stolen or destroyed.
3. Vouchers are sold subject to The Vendor’s right to alter the advertised terms as reasonably necessary. No refund will be owed should a change to the advertised offer occur.
4. All Vouchers may not be altered, modified, copied or reproduced in any way without prior written consent from The Vendor and / or The Agent.
5. All Vouchers are for personal use only. The resale or use of Vouchers for any form of business or commercial activity is strictly prohibited unless given prior written consent from The Agent.

6. Personal arrangements including travel, subsistence, hospitality or accommodation relating to the voucher's use are at your own risk. Neither the Vendor, the Agent nor the Venue shall be liable for any loss or refund.
7. This voucher is non-refundable and cannot be exchanged for cash in part or full and is valid for a single transaction only.
8. This voucher can be used and / or combined with additional Time Out Tab Voucher(s) in a single transaction.
9. The Merchant reserves the right to refuse you entry to and/or eject you from the Venue (and may take appropriate action to enforce this right) in circumstances, including without limitation:
 - a. Health and safety or licensing reasons
 - b. Behaviour in a manner that has or is likely to affect the enjoyment of other persons at the Venue or
 - c. If you use or display threatening, abusive or insulting words or mannerisms or behave in a manner which may provoke a breach of the peace,
 - d. If, in the Venue's sole discretion, you appear to be acting under the excessive influence of alcohol or under the influence of drugs,
 - e. If you refuse to comply with any search required by the Promoter,

 - g. If your Voucher is void.
 - h. If you fail to conform to UAE customs and practice for Arab Gulf Co-operational Council National Dress.
